

2. How can OvidMD help me?

An example scenario

Problem:

A patient of yours suffering from multiple sclerosis (MS) has been taking beta-interferon by injection for many years.

During a consultation the patient produces a newspaper article on an oral medication (Gilenya Capsules/Fingolimod) that apparently is being used in the treatment of MS. The patient wants reassurance that they are still receiving the best treatment for them.

2. How can OvidMD help me?

An example scenario


Solution:

- ✓ Turn to OvidMD in the course of the consultation.

- ✓ Locate the relevant information in full text.

- ✓ Refer to <u>authoritative and reliable resources</u> in your discussion with the patient regarding the suitability of currently available oral medication for their type of MS.

Assisted searching

Example scenario solution (1/7):

Auto-complete: provides up to ten suggested terms from the LEXI controlled vocabulary. The list of suggested terms will be refreshed with each keystroke.



The search is automatically carried out through "Everything" i.e. through all the OvidMD resources available on subscription.


OvidMD is the only medical search engine that spans UpToDate®, MEDLINE, and Ovid full-text in one fast search.

The search can be made more specific (i.e. by adding the phrase "oral medication") in order to retrieve information that is both current as well as relevant.




Example scenario solution (4/7):

OvidMD provides information in full text.


Articles are available as PDF files as well as HTML based documents for better integration of the relevant information into your own documents and information resources.




